DIRECTOR NEWSLETTER

Greetings! As your elected representative on Intermountain Rural Electric Association's board of directors, I have several pieces of association news to share:

CAPITAL CREDITS

I am happy to announce that IREA will issue capital credits once again this year.

My fellow board members and I voted last month to refund \$16.1 million. If you purchased electricity from us prior to 2020, you will receive your share of that refund.

Most current customers will see the refund as a line item on their March bill. To receive a check instead of a bill credit, click the Bill Credit Opt In/Out link under Capital Credits on our website, www.IREA.coop. Your opt-out request must be submitted by Feb. 27 to receive a check this year.

In the past seven years, IREA has returned more than \$105 million in capital credits.

RENEWABLE ENERGY

IREA's investment in renewable energy will continue growing in 2020. We expect another 80 megawatts of solar-generated power when the Pioneer Solar facility comes online by the end of the year. Before year end we will have nearly 100 megawatts of solar generation in production with more under contract and slated to come online in 2021.

Our solar power purchases are made under the Public Utility Regulatory Policies Act. IREA pays avoided cost, which is what we would otherwise pay for the same amount of energy from other sources.

We expect to have nearly 200 megawatts of solar energy producing by 2025, in addition to more than 16 megawatts of distributed generation from customers currently interconnected to our system. I am committed to looking at all options for the integration of reliable energy into our system.

RENEWABLE ENERGY CREDITS (RECs)

Do you want to support renewable energy without installing a solar or wind system? Consider purchasing Renewable Energy Credits (RECs) through IREA.

Each REC is "proof" that 1 kilowatt-hour (kWh) of

electricity was generated through a renewable energy source and distributed to the grid. The purchase of RECs does not mean you will receive additional green power at your home or business, but does support the production of renewable energy and entitles you to claim the environmental attributes.

Our current prices are 5.5 cents per kWh of solar and 1 cent per kWh of wind. You have the option to either make a one-time purchase or add a recurring amount of \$5 or more to your monthly IREA bill.

PAYMENT OPTIONS

IREA has recently introduced several features that improve the payment process:

- Customers enrolled in electronic billing can make credit or debit card payments from within their eBill.
- A new guest log-in feature makes it easier for family, caretakers, and other guests to pay on behalf of an IREA account holder.
- Recurring credit/debit card payments also are available. There is a transaction limit of \$500 so consider automatic payments via a savings or checking account if your bill typically exceeds \$500.

These new options are in addition to the elimination of fees associated with all electronic payments, which the board approved last year.

FIRE MITIGATION PLAN

I am keenly aware of the threat of fire in parts of IREA's service territory. We have seen the devastation in Northern California and the highly controversial plans by their California utility in promoting rolling blackouts. At IREA we recognize the need in addressing the threat of fires and seek to continue our goal of providing reliable electric service to avoid the need for blackouts. We foresaw the threats many years ago and, with board leadership, moved quickly into plans to continue the reliability of our service. IREA is now in the second six-year phase of our vegetation management program that we initiated in 2014. Our previously initiated comprehensive fire mitigation plan addresses four key areas: operating practices, design standards, maintenance and tree trimming. Our tree-trimming program recently began a new six-year cycle

in which vegetation management crews will clear all overhead distribution lines within IREA’s service territory. IREA’s tree trimming program has expended millions of dollars in this important effort.

We will send a mailed notice if trimming is planned in your area; an additional notice will be left on your door if any work takes place on your property. Crews typically work 7 a.m. to 5 p.m. Monday through Thursday. Call our Utility Forester at (720) 733-5632 if you see tree-trimming crews in your area and would like wood chips, which are free to IREA customers.

Please call us immediately at **(800) 332-9540** if you spot a potentially hazardous tree or other vegetation near our power lines.

POLE ATTACHMENT AUDITS

IREA audits attachments to our poles on a five-year cycle. These attachments are not owned by us and typically include communication lines such as broadband, telephone and cable television. The audit confirms placement of the attachments and identifies those that might not meet industry standards, which are then addressed by attachment owners. Work on this year’s audit will take place through the spring and summer and will be generally performed using drones to minimize field work.
